Notice of Food Safety Product Recall

26 July 2021

Dear Customer

As part of our routine quality control procedures, we have unfortunately identified a deficiency in the side seam weld of an extremely small number of cans manufactured by a third-party supplier that could lead to cans developing a leak. The issue affects various KOO and Hugo's canned vegetable products.

No health issues, due to the potentially leaky cans, have been reported to date. Although the likelihood of a health safety risk is extremely low, matters of quality and food safety are non-negotiable for Tiger Brands. The company in consultation with the National Consumer Commission (NCC) therefore made the decision to initiate a withdrawal in the best interest of consumers.

Canned products forming part of this recall, covers various KOO canned vegetable products, Hugo's Baked Beans and Helderberg Peas that were **produced between 1 May 2019 to 5 May 2021** as specified in the first table below. The recall excludes all KOO canned fruit products, KOO Pilchards and KOO products packaged in glass.
